To protect yourself and others, get vaccinated as soon as possible. It helps to achieve herd immunity and boost the better recovery of Hong Kong society and economy.

China Taiping Insurance (HK) Company Limited (hereinafter referred to as "CTPI(HK)") actively fulfills its corporate social responsibility. Special discounts and additional allowances will be offered to COVID-19 vaccinated customers when they apply for selected insurance plans. Details are as follows:

1. Promotion Period

From 7 June 2021 to 31 December 2021

2. Eligibility

Customers* who have received their first dose of approved COVID-19 vaccine before 30 September 2021 will be eligible to apply for the special offers.

Note: * Customer refers to the policyholder or the insured. Either the policyholder or one of the insured must meet the above requirements. The customer must provide a photocopy of the "COVID-19 vaccination record (with name and ID number shown)" issued in Hong Kong when applying for insurance plans to enjoy the special offers.

3. Special Offers

(1) "New Taiping Comprehensive Travel Insurance Scheme" and "Taiping Cruise Travel Insurance Scheme"

- Enjoy 12% premium discount;
- Enjoy additional allowances as follows:

1) Vaccine invalidation allowance: HKD1,000

The Eligible Insured Person may be reimbursed if diagnosed with COVID-19 within three months after receiving the last dose of the approved vaccine and provides relevant supporting documents.

2) COVID-19 death allowance: HKD50,000

(only applicable to "New Taiping Comprehensive Travel Insurance Scheme" one-year policy)
If the Eligible Insured Person is diagnosed with COVID-19 within three months after receiving the last dose of the approved vaccine during the insurance period, and dies directly from COVID-19 within 30 days of the date of diagnosis, he/she will receive a lump sum death allowance.

(2) Domestic Care Insurance Scheme

- Enjoy 10% premium discount

(3) Domestic Helper Insurance

Policyholder(s) or Insured Domestic Helper(s) who are placed under compulsory quarantine* by the HKSAR government in designated quarantine centre(s) or public hospital(s) will receive daily

quarantine living allowance of HKD300 per day, with maximum compensation up to HKD5,000 per policy

Note: * Not applicable to inbound travellers who are required to undergo compulsory quarantine or persons receiving home quarantine.
