As border control measures loosen worldwide, please be advised from the date of this announcement, Taiping HK shall revise the benefits and application requirements related to the COVID-19 for our travel insurances, summarize as below:

Applicable Product	All travel insurances with covid-19 related benefits
Application region	Countries/regions outside Hong Kong that are already covered in the original policy
Special application requirement	<ul style="list-style-type: none"> (i) Only applicable to independent travelling (ii) The Insured Person, at the time of applying this insurance, has been fully vaccinated with any COVID-19 vaccine recommended by the Hong Kong government; Vaccination Medical Exemption Certificate shall not be included; (iii) The Insured Person has fulfilled the entry requirement for the destination (country/region); (iv) The Insured Person is aged 75 or below; (v) PCR positive test results must be provided as proof of claims;
Medical related benefits	(Only applicable to policies with COVID-19 medical expenses benefits)
Medical expenses	Overseas Medical Expenses incurred directly due to the Insured Person contracting COVID-19 during the Insured Journey within the Period of Insurance for Eligible Expenses which is necessarily outside Hong Kong <ul style="list-style-type: none"> • Aged 18 to 65: up to the Maximum Benefit as stated in the Table of Benefits or a sub-limit of HK\$1,000,000 per Insured Person and per Insured Journey, whichever is lower • Aged 66to 75: Half of the Maximum Benefit for insured Aged 18 to 65 • Aged below 18: 1/4th of the Maximum Benefit of insured person aged 18 to 65
Cancellation/ Curtailment of Journey	(Only applicable to policies with COVID-19 trip cancellation/shortening benefits)
Cancellation of Journey	Cancellation of Journey benefits which includes Travel Ticket, accommodation, tour packages which are irrecoverable from any other sources incurred directly due to the Insured Person contracting COVID-19 after the Effective Date and within the period of seven (7) days before the scheduled departure date of the Insured Journey, up to the Maximum Benefit as stated in the Table of Benefits
Curtailment of Journey	Curtailment of Journey which includes Travel Ticket, accommodation, tour packages which are irrecoverable from any other sources and incurred directly due to the Insured Person contracting COVID-19 during the Insured Journey, up to the Maximum Benefit as stated in the Table of Benefits

1. This announcement shall automatically supersede any previous measures announced and related to the above benefits and products. Other benefits shall remain unchanged, for details please refer to the terms and conditions of the policy.
